REPORT ON THE FINANCIAL STATEMENTS

We have audited the accompanying financial statements of M/s. EP BIOCOMPOSITES LIMITED ('the Company'), which comprise the Balance Sheet as at 31st March 2020, the Statement of Profit and Loss for the period from 17th January, 2020 to 31st March, 2020 and the statement of Cash Flows for the period then ended and a summary of significant accounting policies and other explanatory information.
